- (v) Cost of Tender document: **Rs. 1000/- (rupees one thousand only)** and **EMD: Rs. 15,000 /- (Fifteen Thousand Only)** separately for each type of tender payable by net banking /RTGS/NEFT, in favour of "PRINCIPAL, GOVERNMENT WOMEN'S POLYTECHNIC COLLEGE, BHOPAL".

- (vii) Contact Person: Officer in charge.

### 3- **Mandatory Documents:**

All bidders must enclose:

- a. Copy of valid GSTN registration certificate.
- b. Bidders of <u>E-waste tender</u> must submit copy of valid registration certificate from Ministry of Environment and Forest /Central Pollution Control Board / M.P. State Pollution Control Board/ any other state pollution control board etc. regarding **disposal of E-waste**, in addition to the above.

#### 4- Period of validity of Bid:-

The bid shall remain valid for <u>60 days</u> after the date of bid opening. If any bidder withdraws his tender before the said period, Principal, Govt. Women's polytechnic College, Bhopal shall be at liberty to forfeit the bid security amount absolutely.

#### 5- General Terms and Conditions: -

- (i) GST or any other taxes/duties as applicable at the time of auction shall be charged extra
- (ii) Each page of tender document should be signed by the bidder (s) in token of acceptance of terms and conditions of tender.
- (iii) Incomplete and unsigned quotations are liable to be rejected.
- (iv) Tender form is attached with the tender notice as Annexure "A" (for Old obsolete Ewaste) and Annexure "B" (Items Scrap and other office waste).
- (v) The successful bidder of **E-WASTE** tender needs to submit an undertaking that all the e-waste will be disposed off as per latest **E-WASTE** (Management and Handing) Rules notified by Ministry of Environment and Forest, GOI, NGT or any amendment thereof.
- (vi) An **earnest money Deposit of Rs. 15,000/- (Rupees Fifteen Thousand only)** must accompany each bid. This shall be submit online in the form of net banking/RTGS/NEFT in favour of "Principal, Govt. Women's polytechnic College, Bhopal" Payable at "BHOPAL" without which the tender shall be summarily rejected. No. Cheque/money Order shall be accepted. The EMD deposit shall not attract any interest.
- (vii) The bidders may inspect the items on predetermined dates and satisfy themselves about the items they are bidding for.
- (viii) The items shall be sold to the **highest price of bidder.**
- (ix) The Earnest Money Deposit of the successful bidder shall be adjusted in the bid forthwith. The EMD of unsuccessful bidders shall be returned within one month of the auction date, without any interest.
- (x) Govt. Women's polytechnic College shall take no items, once disposed to the successful bidder, back.
- (xi) The successful bidder has to make full balance payment in the form of Demand Draft/pay order of any Nationalized/Schedule Bank drawn in favor of "Principal, Govt. Women's polytechnic College, Bhopal" payable at "BHOPAL" within 7 working days after confirmation, failing which the offer may be canceled and EMD shall stand forfeited.
- (xii) The successful bidder shall be required to lift all the items from the disposal site to his premises within 7 working days after the payment of the quoted amount. On failure to do so, Principal, Govt. Women's polytechnic College, Bhopal shall have the right to forfeit the entire amount of the bidder and dispose the items to alternate bidder.
- (xiii) Final decision to accept/reject single or all the bids shall be taken by the Principal, Govt. Women's polytechnic College, Bhopal.
- (xiv) The successful bidder shall be required to install Heavy Electronics Weight Machine to weigh (Scrap and other office waste) in the college premises with own expenses
- (xv) All the other expensive like labour charges, transportation charges, weighing charges etc, liable to pay by bidder itself.
- (xvi) All legal disputes related to the above tender shall be subjected to Bhopal jurisdiction only.

#### **6. Bidding Procedure**

- i. Bid shall be submitted online in the prescribed format.
- ii. No Bid will be accepted after this date and time under any circumstances.
- iii. This office will not be responsible for any delay and also for reasons beyond the control of this office.
- iv. Each Bid must be accompanied by a **tender document fees of Rs.1000/- (rupees one thousand only)** and **bid security (EMD)** of the amount of **Rs. 15,000/- (Rupees Fifteen Thousand only)** submit online in the form of net banking/RTGS/NEFT in favour of "Principal, Govt. Women's polytechnic College, Bhopal".
- v. Bids without EMD and tender fees will be summarily rejected.
- vi. No exemption allowed for EMD and tender fee.
- vii. All relevant Government rules and regulations will be final and applicable & binding to all bidders.

#### 7- Online Submission of Bids: -
